Summary: The trustee board convened via Zoom on Thursday, December 10, 2020 at 7:00 p.m. It was a special meeting that included the introduction of Dr. Robert Griffin, Academic Dean of MSCC. The introduction came after Dr. Griffin consented to be one of our faculty members for the 2021 academic year. He was received with a heartfelt welcome from the board members.

There was only one question posed to him, regarding diversity within the school and among faculty members. His response focused on his experience working in an environment that promoted inclusivity. He also mentioned his continuous support for the African American community. Dr. Griffin was excused from the meeting around 7:45 p.m.

The meeting continued, addressing the agenda items. Each trustee board member received a packet that included the agenda and other pertinent information.

We briefly reviewed the board's purpose, the status of AIHC-SBS, including partnerships. A special announcement about the partnership between AIHC-SBS and MSCC was declared official. Chancellor Thomas interjected the meaning of an articulation agreement, as the agreement that binds the partnership between our school and MSCC (Mid-South Christian College). We also announced the signing ceremony event to solidify this partnership.

Chancellor Thomas discussed the flow of revenue stream in the school. He informed the board members of the financial support received from the pastors of AIHC, student tuition, and the alumni support team.

I updated the board on the upcoming school year, change in the term dates which will provide more instruction time during the 3<sup>rd</sup> term, and the new course number assignments.

At the conclusion of the meeting, one of the board members suggested that everyone should receive some information/training on the language that should be used as we promote the school.

Chairman Greg Thomas made final remarks and the benediction.
